Assigned to House Motor Vehicles Committee	Relates to automobile accidents and the use of cell phones. This bill also changes the point system associated with driver's licenses.
	HB 6	Representatives Bobby Franklin of 43 rd and Bobby Reese of 98 th	Carrying and possession of firearms during certain emergencies This bill relates to firearms possession during certain emergencies as declared by the Governor. This bill will prohibit the confiscation of a weapon by any law enforcement officer or National Guard member during a state of emergency and stipulates that a law enforcement officer will be subject to personal liability and payment of court costs if they are personally sued. NOTE: A special GACP Alert was sent out on 1/31/07 about this bill. At the 2-18 GACP Executive Board Meeting, the Board voted to oppose this legislation, as currently written.	Favorable reported from House Judiciary Non-Civil Committee. House Rules Committee 1-30-07	Would eliminate the Governor's authority to suspend sales or transportation of firearms during declared emergencies. Additionally, prohibits law enforcement, Nation Guard personnel from taking guns away from citizens during declared emergencies. Provides for personal liability "against" law enforcement officers.
**	HB 48	Representatives Jim Chambers of 81 st , Timothy Bearden of 68 th and Harry Geisiner of 48 th .	Georgia State Indemnification Fund This bill relates primarily to firefighters that may die within 24 hours after responding to a fire...whether on or off duty. It also will include MARTA police officers in the State Indemnification Fund.	Passed the House on 3/19/07. Moves to the Senate.	House Committee favorably reported on 2/27/07.
	HB 52	Representatives Ronald Forster of the 3 rd , David Ralston of the 7 th , Mary Oliver of the 83 rd , Judy Manning of the 32 nd , and others.	Juvenile Detention This bill would restrict the detention of juveniles. "Interim control or detention shall not be imposed on an accused child under the age of 16; instead, the child shall be released immediately to the child's parents, guardian, or other custodian upon such person's promise to bring the child before the court when requested by the court."	Assigned to House Judiciary Non-Civil Committee	There are many unanswered questions that must be addressed before this bill is worthy of passage.

Georgia Homeland Security Act of 2007 This bill requires colleges and universities to maintain information regarding student visas and report those students who fail to enroll or attend class or who withdraw from school or who otherwise violate the terms of his or her visa.	Assigned to House Education Committee.	The Board of Regents has not officially announced their position on this legislation. Sounds good to me.
	HB 74	Representatives Burke Day of 163 rd , Billy Horne of 71 st , and Jay Neal of 1 st .	Extraterritorial Law Enforcement Jurisdiction This bill allows municipal police to offer assistance to other law enforcement agencies, upon request, anywhere in the state. This bill would allow any officer to leave their jurisdiction and render requested assistance with the approval of his or her employing agency. The officer would have the authority to exercise the powers of arrest to the same extent as any peace officer employed by the law enforcement agency receiving such assistance.	Assigned to House Judiciary Non-Civil Committee	This bill gives the authority to the employing agency; rather than, the elected officials to decide when officers may leave their jurisdiction to provide assistance to a requesting agency. NOTE: GMA does not think this legislation is needed. However, this bill is needed to clearly protect responding officers from liability concerns.
	HB 75	Representatives Burke Day of 163 rd , Billy Horne of 71 st , and Jay Neal of 1 st .	Serious traffic offenses; felony fleeing; attempt to elude police; provisions This bill will increase the penalties for fleeing or attempting to elude a police officer.	Assigned to House Judiciary Non-Civil Committee	Cross referenced to SB 91. Movement on the above Senate bill with changes from the original offering.
**	HB 77	Representatives Bobby Franklin of 43 rd , Martin Scott of 2 nd , Barry Loudermilk of 14 th , John Lunsford of 110 th , Robert Mumford of 95 th and Charlice Byrd of 20 th .	Repeal of Red Light Camera Enforcement This bill repeals the statutory authority of cities to utilize red light camera enforcement technology to improve safety at intersections. At the 2-18-07 GACP Executive Board meeting, the Board voted to oppose this bill as currently written. On 2-27-07 a major substitute was offered on this bill.	Amended bill passed the House on 3/20/07. It now moves to the Senate.	NOTE: GMA, ACCG and GACP are opposed to this legislation. The revised bill requires cities and counties to turn over a portion of the fines they raise with the cameras to the State for the network of trauma care hospitals. Local governments would also have to do traffic engineering studies at intersections before installing the cameras so they could potentially find alternatives.

The Board reaffirmed their opposition at the 2-18-07 Executive Board Meeting. The focus of GACP's opposition had to do with officer safety. A letter was sent to House members; however, the House still elected to pass the bill. The bill is now in the hands of the Senate Rules Committee.</p> <p>Please read the Bill and call your State Senator opposing this dangerous piece of legislation. Death penalty; jury findings; aggravating circumstance; Allows the death penalty to be imposed where the jury finds at least one aggravating circumstance but is unable to reach a unanimous verdict as to the sentence. Only ten jurors (instead of 12) are required with this bill.	Passed the House on 3/20/07. It now moves to the Senate.	This bill still give judges discretion to impose life, with or without parole, instead of death on an 11-1 or 10-2 verdict. A unanimous jury verdict would automatically lead to a death sentence. The bill only addresses the sentencing stage of a trial and does not change the guilt or innocence phase of a verdict. Unanimity is still required for a judgment of guilt.

At the 2-18-07 GACP Executive Board meeting, the Board voted to oppose this legislation. In part, based upon our opposition, the author has agreed to alter the path of the bill.	Assigned to House Judiciary Non-Civil Committee	It will be very difficult for many of the smaller agencies to comply with the procedures specified. Additionally, time will be needed to train officers to adhere to these new procedures. Some have said that this legislation is a defense attorney's bill. Traffic Offenses; fleeing/attempting to elude a pursuing police vehicle This bill will increase the penalties for fleeing or attempting to elude a police officer.	Passed Senate. Moves to House. Assigned to the House Judiciary Non Civil Committee.	Makes it a felony (1-5 years confinement or fine up to \$5,000). As passed by substitute, the felony kicks-in only upon a second conviction. Substitute bill passed the Senate on 3/1/07.
SB 125	Senators Chance of 16th	Super Speeders This bill will increase speeding fines (85 mph or more anywhere in Georgia and 75 mph or more on a two lane road will be classified as a “super speeding” offense, adding an additional fine of \$200). The additional fees, after administrative costs, will go to the State’s general treasury with the intent that the money will be used to fund a trauma care system.	Assigned to the Senate Rules Committee	Local governments would not be responsible for collecting additional money as an add-on. Most who care about public safety like this bill for it acts as a control to cut down on “excessive speeding”.

SB 259	Senator Fort of the 39 th and Mullis of the 53rd	No-Knock Warrants-Restrictions Warrants of this nature could only be issued if there is clear and convincing evidence of imminent danger to human life. Additionally, all warrants of this type must have affidavits supporting the warrant. There is no mention of evidence destruction in this bill. <i>NOTE:</i> The original bill was extremely restrictive, almost eliminating the basics for no-knock warrants. However, the substitute bill that passed was modified because of GACP’s efforts. In the original version of this bill, clear and convincing evidence was needed for a no-knock warrant. The substitute bill only requires probable cause. Nevertheless, GACP is still concerned about this legislation because we do not think it is necessary.	Senate Judiciary Committee	This bill was introduced because of a recent issue that took place in Atlanta which resulted in the death of an elderly woman. Senate Judiciary Committee unanimously approved changes that require police officers to meet a stiffer standard (probable cause) to get the special warrants, which are intended to prevent suspects from getting rid of evidence and to protect officers from potentially violent suspects.
