#### **Presentation of Previous Minutes**

Executive Director Rotondo presented the minutes of the previous board meeting for review. Motion made by Warden Dennis Nelson and seconded by Chief Joseph Wirthman to accept the minutes of the January 3, 2017 Board Meeting as presented. Motion passed unanimously.

#### **Financial Report**

Executive Director Rotondo distributed to all board members a copy of GACP's financial report dated December 31, 2016. Motion made by *Director Dan Branch* and seconded by *Chief Wesley Walker* to accept the financial reports dated December 31, 2016 as presented. Motion passed unanimously.

#### **Executive Director's Report**

- > Reintroduction of Account Manager Kevin Sifferlen of LexisNexis Coplogic Solutions
  - Mr. Sifferlen spoke briefly about the progress of law enforcement agencies in Georgia in remitting accident reports to the state database electronically. Mr. Sifferlen said that Georgia was one of the highest contributors throughout the nation in submitting accident reports in this manner.

- ➤ Life Membership Ray Folsom, Camilla PD
  - Executive Director Rotondo asked the Board to consider Life Membership for Chief Ray
    Folsom of Camilla PD, who will be retiring effective March 10, 2017. Executive Director
    Rotondo advised Chief Folsom qualifies for Life Membership. Motion made by Director Dan
    Branch and seconded by Chief Tony Tanner to grant Life Membership to Ray Folsom
    effective March 10, 2017. Motion passed unanimously.
- ➤ Life Membership Gary George, Retired Chief of Alpharetta PD
  - Executive Director Rotondo requested the Board consider Life Membership for retired Chief Gary George of Alpharetta PD. Chief George qualifies for Life Membership. Motion made by Chief Joseph Wirthman and seconded by Warden Dennis Nelson to grant Life Membership to Gary George. Motion passed unanimously.
- Life Membership Michael "Steve" Smith, Retired Marshal of Richmond County Marshal's Office
  - Executive Director Rotondo asked the Board to consider Life Membership for Marshal Michael "Steve" Smith of Richmond County Marshal's Office. Marshal Smith's membership in GACP was as an appointed official for many years. However, about a decade or so ago, the governing authority changed the Marshal's position to an elected position of which he maintained until retirement. Regardless, Marshall Smith qualifies under the GACP Constitution for Life Membership as a special consideration. Motion made by Warden Dennis Nelson and seconded by Director Dan Branch to grant Life Membership to Gary George. Motion passed unanimously.
- Life Membership Steve Land, Retired Chief of Hazlehurst PD
  - Executive Director Rotondo asked the Board to consider Life Membership for retired Chief Steve Land of Hazlehurst PD as he met the criteria for Life Membership. Motion made by Chief Wesley Walker and seconded by Chief Joseph Wirthman to grant Life Membership to Steve Land. Motion passed unanimously.
- ➤ GSA Law Enforcement Compensation Discussion
  - Chief Grogan spoke extensively about the Georgia Sheriff's Association (GSA) Law Enforcement Compensation Resolution and presented documents which provided additional information about the feasibility of implementing some, if not all, of the points in the GSA Resolution. President Grogan also noted that he spoke with the president of the GSA and was advised that they do not have a legislative author interested in introducing a bill to support any of the points associated with the GSA Resolution. President Grogan indicated that he asked the Constitution/By-Laws/Resolutions Chairperson, Chief Mark Welsh of Elberton PD to draft a GACP Resolution titled Support of Reviewing Law Enforcement Salaries. President Grogan read the substance of that resolution for the attendees. Upon conclusion of the resolution reading a motion was made by Chief Joseph Wirthman and seconded by Director Dan Branch to approve the GACP Resolution titled Support of Reviewing Law Enforcement Salaries (copy of resolution attached)
- ➤ Update of Training (New Hours/2017)
  - Executive Director Rotondo told all the members in attendance that Directors Vance and Wigginton will be speaking before Wednesday's training program about the new required training hours effective January 1, 2017.
- Amici Curiae Brief
  - Executive Director Rotondo spoke briefly about a request that the Executive Board support an Amici Curiae Brief associated with "transgender boys". After a discussion involving all board members including the GACP attorney, a motion was made by Chief Tony Tanner and

seconded by *Director Dan Branch* that GACP remain neutral on this issue and not support the Amici Curiae Brief. Motion passed unanimously.

- Chief's Day at Capitol
  - Executive Director Rotondo indicated that Chief's Day at the Capitol is scheduled for March 14, 2017 further information will be distributed to the members via email.
- ➤ Legislative Information
  - Executive Director Rotondo went over some points regarding introduced legislation. Some of the legislative areas that were highlighted during his presentation were HB146, SB45, SB15, SB90, SB42, HB116, and HB79.

  - President Grogan spoke about an Appleseed project which basically involved GACP working closely with Appleseed group to repair the ties of society with professional law enforcement standards.
- Prostate Cancer Coalition
